

# DEVELOPMENT PERMIT AREA 6 INFILL DEVELOPMENT FORM & CHARACTER APPLICATION REQUIREMENTS

A Guide to the Municipal Approvals Process in Chilliwack September 2017

## **INTRODUCTION:**

<u>Development Permit Area 6 – Infill Development Form & Character</u> is comprised of all properties outside of DPA 5, designated for commercial, multi-family residential and mixed commercial-residential development in the City of Chilliwack. ### **PURPOSE AND OBJECTIVES:**

- 1. To encourage a high standard of site and building design through the establishment of clear design guidelines for new commercial and multi-family residential infill development;
- 2. To maintain a consistent streetscape, promote pedestrian scale and enhance the urban design of the surrounding community; and
- 3. To facilitate the orderly development of the area and to encourage coordination of the siting, form and volume of new commercial and intensive/multi-family residential buildings and their areas for parking, storage, signage and landscaping.

## DEVELOPMENT PERMIT IS REQUIRED FOR THE FOLLOWING WORK AND ACTIVITIES:

- Construction of new commercial, intensive/multi-family residential, and mixed commercial residential development, including free standing signs;
- Addition to, or exterior alteration of, a commercial or intensive/multi-family residential development, including free standing signs.

### **APPLICATION REQUIREMENTS:**

- 1. Brief Written Description of the proposal and how it meets the design guidelines.
- 2. <u>Site Plan</u> of the proposed development showing lot configuration and dimensioned locations of buildings, parking access and structures at an appropriate metric scale.
- 3. <u>Landscape Plan</u>, at an appropriate metric scale, showing proposed landscape areas and species, and proposed treatment of other surfaces not covered by buildings. This plan should show retaining walls, walkways, amenity areas, waste disposal areas, and screening.

- 4. <u>Colour Exterior Elevations</u> to fully explain the proposal. These elevations are to indicate proposed and existing building materials in a realistic colour rendering.
- 5. <u>Colour and Material Samples Board</u> for all proposed structures (i.e. awning fabrics, stucco, metals, wood, etc.).

## ADDITIONAL INFORMATION THAT MAY BE REQUIRED:

- 1. <u>Cross Section</u> of proposed awnings or canopies, indicating dimension and height above the sidewalk.
- 2. **Photographs** of existing site and buildings, including portions of adjacent properties and/or buildings.

### **ADDITIONAL COMMENTS:**

The Design Review process requires a "clear picture" of the intended works to be undertaken. Failure of the Development Permit applicant to supply all necessary documents and materials may result in a delay of the application until the submission requirements are fulfilled.

One hard copy and one electronic copy of all information are to be provided for review.
