Elector Registration (for voting day only registration)

There is no need to pre-register to vote, as the registration of all electors for this election will take place at the time of voting. You will be required to make a declaration that you meet the following requirements:

- 18 years of age or older, or will be on general voting day;
- a Canadian citizen;
- resident of B.C. for at least 6 months immediately preceding voting day;
- resident of OR registered owner of real property in the City of Chilliwack for at least 30 days immediately preceding voting day; and,
- not otherwise disqualified by law from voting.

**Resident electors** will also be required to produce **2 pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

**Non-resident property electors** must complete an “Application for Registration as a Non-Resident Property Elector – Form No. 2-7” AND produce 2 pieces of identification (at least one with a signature) that provide evidence of identity.

Non-resident property elector “Application for Registration as a Non-Resident Property Elector – Form No. 2-7” can be obtained from the City Clerk’s office at the City of Chilliwack during regular office hours prior to 4:30 p.m. on Friday, November 14, 2008. On Advance Voting days, applications can be obtained from the Deputy Chief Election Officer at the City of Chilliwack.
