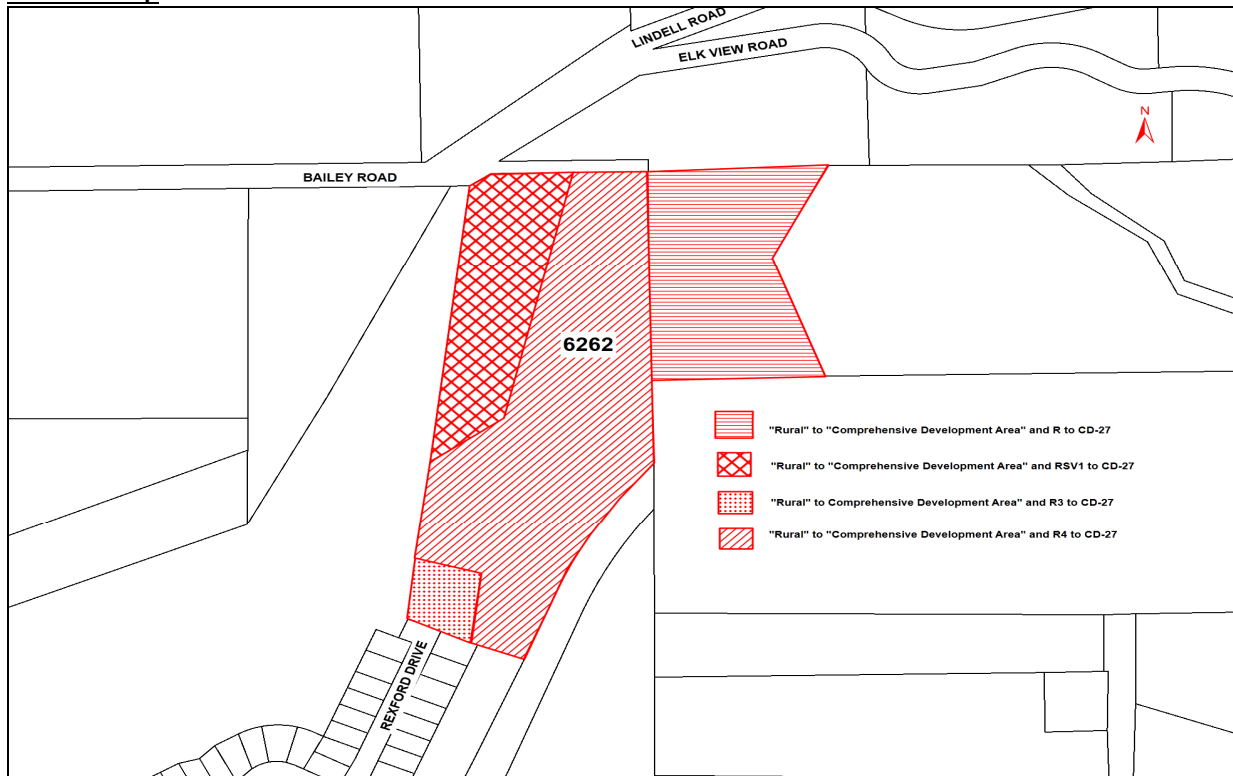

Purpose: To realign the boundary of the Official Community Plan Neighbourhood Plan "Map 1" to include the property located at 6262 Rexford Drive within the Promontory neighbourhood, as shown on the map below.

Purpose: To create a new CD-27 (Comprehensive Development-27) Zone to facilitate a residential development within 6262 Rexford Drive, as shown on the map below.

Location: 6262 Rexford Drive
Applicant: Doug Dueck
Purpose: To rezone the subject property from an R3 (Small Lot One Family Residential) Zone, an R4 (Low Density Multi-Family Residential) Zone, an R (Rural) Zone and an RSV1 (Limited Use Reserve) Zone to a CD-27 (Comprehensive Development-27) Zone to facilitate a residential development, as shown on the map below.
